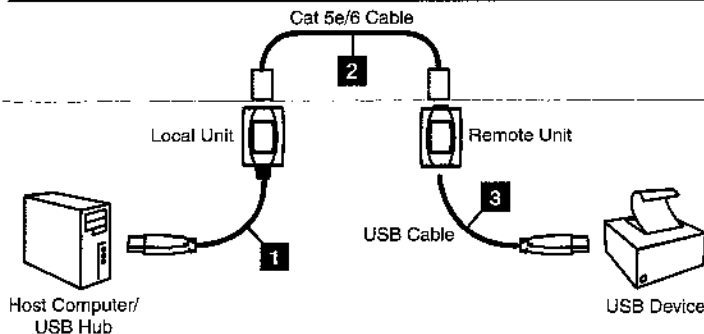

Installation



Note: Diagram shows the B202-150. Connections will be the same for the B202-150-WP, except separate USB A/B device cables will be needed.

- 1 Connect the USB A connector on the B202-150 local unit to the host computer; or, connect the B202-150-WP local unit to the host computer using a user supplied USB device cable.
- 2 Connect the RJ45 ports on the local and remote units using user supplied Cat5e/6 cabling. The Green LED on the local unit will illuminate to indicate it is connected to and receiving power from a host computer. The Orange LED on the local unit will illuminate to indicate it is connected to the remote unit via Cat5e/6 cable. The Orange and Green LEDs on the remote unit will illuminate to indicate it is connected to and receiving power from the local unit.
- 3 Connect the remote unit to the USB device using a user supplied USB device cable.
